# Why I am nominating for the Youth Action Board?

As someone who is fervent about fostering a generation of zealous and ambitious pioneers, having the opportunity to engage with like-minded civic leaders who represent the diversity needed in the decision-making sphere would be a truly invaluable experience. It has been a turbulent time to come of age. Although young people are frequently labeled as apathetic or disengaged from politics, scenes from climate rallies and the outpouring of support for mental health awareness in recent years show just how outdated this stereotype is. As such, being a member of the Youth Action Board would be a fulfilling role to advocate for positive change on issues affecting young people, fostering a society where all NSW young people are supported, engaged and valued. By adopting a rights-based lens to focus on programs, policy and advocacy, all of which are informed by a data and evidence-based approach, meaningful outcomes can be achieved.



# My connection to young people / youth work / the youth sector:

As someone who is deeply passionate about social justice, storytelling and the young pioneers of our generation, my passion for elevating the voices of young people from politically marginalised backgrounds is an enduring challenge that I am passionate about. My association with UN Youth Australia has enabled strong connections with young people. My role as a facilitator engages with delegates through peer-to-peer education, exploring global issues through rich discussion and debate. This relationship has been enhanced by being a National Education Committee Member and as last year's Report Writer which engaged with the UN Youth Australia Representative to assist with writing and editing content for the Youth Representative Report. As a young carer, I am familiar with how the analytical framework of intersectionality contributes to young people's experiences and forms a significant part of their identity. As such, I will take a compassionate approach to dealing with various concerns in the youth sector.

# What skills and experience would I bring to the Youth Action Board?

I will be bringing experience gained from my membership to Youth Action's Western Sydney Outburst Network. This has sparked collaboration with Sydney Morning Herald's election coverage of young people who shared how meaningful policy on climate change, housing affordability, education and integrity in politics influenced their vote. This was a genuinely empowering experience. Further collaboration on the NSW Election Forum facilitated an invigorating discussion that elevated the voices of young people. As an elected General Councillor and more recently, Assistant General Secretary, on the University of Technology Sydney's peak governing body, the SRC, I have borne witness to the extraordinary feats and achievements spearheaded by young people. My active desire for positive development in student life has been demonstrated through my involvement in social justice projects and collectives. At a local government level, my membership to Blacktown City Council's Youth Advisory Committee has stimulated positive interpersonal relationships and collaboration. As a former Youth Ambassador, being actively involved in organising and hosting events like the Unleash the



Future MMIXX NSW Youth Council Conference broadened my horizons into the myriad of issues facing young people. My involvement in the coordination of events has taught me that a leader is somebody who lifts while they climb and consistently endeavours to maximise the efforts of others.

#### **About me**

My name is Flynn, I'm 19, and I study a Bachelor of Communication full-time while working as a student union representative. I was born in Aotearoa New Zealand, but have called Australia home for as long as I can remember. I grew up on the lands of the Darumbal people in Central Queensland, far from any major cities. Here I studied High School via distance education, while at the same time battling with mental health issues, some that have still followed me today. It was there that my fiery passion for youth was sparked by the intense resilience of young people in regional and rural areas. I very quickly realised growing up that youth are disadvantaged, especially those in regional and rural areas. Going forward, I'm hoping to help change that by ensuring all youth, no matter their age, gender, culture, or location have access to the same resources and support

## Why I am nominating for the Youth Action Board?

I've recently moved from regional QLD to regional NSW, in Armidale. What I've seen in my time here is that it's much the same. Youth are held back from reaching their full potential. Youth Action has a vision of working 'towards a society where all NSW young people are supported, engaged, valued, and have their rights realised'. I want to help realise that vision. Furthermore, I want to ensure that vision does not just stop in Sydney. I have a connection to regional and rural areas, and I want to see them provided with the same support, engagement, value and rights as those in a city. It is exponentially harder for youth to access support in regional areas, especially those from the LGBTIQA+ community, those with a



disability, those from diverse communities, and the list goes on. I want to be apart of the process that helps change that.

# My connection to young people / youth work / the youth sector:

My main connection to young people is that I am a young person. However, it goes deeper than that. While I've only recently moved to NSW, I've been very much involved with the youth sector in QLD. I've always had the passion of supporting other youth, and while it may sound cliché, it started with being school captain in high school. Especially studying via distance with students spread out across such as wide area, they needed the support I could offer. I've always been there to volunteer locally and help out where I could. I was elected to the position of Youth Minister for the Environment, which expanded on my connection to the sector, allowing me to communicate concerns with politicians and work alongside them. I currently represent student interests and provide a voice for uni students as a student union representative as well.

## What skills and experience would I bring to the Youth Action Board?

Through my work as Youth Minister for the Environment, I managed a portfolio of 11 other young people, mostly high school age. I facilitated their own professional development while ensuring they were confidently able to write legislation relevant to their assigned positions. My main experience relevant to the board stems from my work as a student union representative. I have experience with boards through being an ordinary member of the College of Business Board, which is responsible for managing the University Business Faculty of over 15 000 students and staff. I have experience heading up committees and sub-committees, predominantly those concerned with policy and sustainability. With a union re-structure slated for next year, it is possible I'll be appointed as Vice-President, furthering the experience gained in that field. Through my professional experience I have an excellent knowledge of the youth sector here in NSW. My employment has been connected to young people and in the youth sector for 25 years, supporting young people facing homelessness, drug and alcohol dependency, risk of radicalisation, child protection and domestic and sexual violence. This has been across charity and Government and has included direct delivery, policy, strategy, funding, participation and celebration.

I Chaired the Board of Directors for a charity who work with young people in the UK for 10 years. I am currently a Director of a charity in Australia who work internationally with women to alleviate poverty. I am currently a charity CEO responsible for the Board of Directors including recruiting, inductions, training, legislation, AGM's and policy. I hold a Diploma in Governance (Australia 2021). I have worked across the private, Government and charity sector in Australia and the UK. Beyond this, my dedication extends to various critical areas that I have had lived experience, advocated within and/or supported young people within including out-of-home care, LGBTQI+ issues, disability rights, mental health, youth justice, youth homelessness, and child protection. I want to help ensure youth voices and lives are always at the forefront of all decisions and actions.

# Why I am nominating for the Youth Action Board?

I started my journey and connection with Youth Action as a young person participating in multiple surveys, reports, and consultations from 18 years of age. I have always held a passion for young people breaking the stigma, using their resilience, strength and experience to shape their own future. I connected with Youth Action because it's one of the platforms where I felt I was respected, my voice was being heard and I was seeing action. I have had the pleasure to be the Deputy Chairperson of the Youth Action Board



since my appointment in October 2021 as a young person at 24. I would be honoured to continue within my role as Deputy Chair or as an individual member to be a voice from diverse experiences, identities and expertise in the Youth sector for I take pride in my responsibilities and commitments. As reflected throughout my aspiration and motivation to be a part of the Youth Action Board, it is rooted in both my personal experiences and my commitment to advocating for change and progress within the youth sector. I value my journey with Youth Action as I feel it is a place where young people's voices, lives and futures sit at the core of their everyday work on their ground.

# My connection to young people / youth work / the youth sector:

My involvement in the youth sector has been extensive with over 8.5 years of experience. Prior to starting my own business, I was a caseworker supporting young people at-risk or experiencing homelessness from 2016 to early 2019 for an NGO. Subsequently, I transitioned into a role as a Youth Development Coach (YDC), where I guided and mentored young people aged 15-21 as they transitioned from out-of-home care to independent living. I was honoured to be a part of so many young people's journeys to support them towards achieving their goals and aspirations. These experiences represent just a fraction of my dedicated work for upholding the rights and participation of young people. 




